

NV Moonbounce Safety Instructions

Jungle Combo Unit - Serial #8755

These safety rules **MUST** be followed to avoid serious injury or death.

***Supervision by a qualified attendant is required at all times.**

1. REMOVE SHOES (ALL PARTICIPANTS MUST BE WEARING SOCKS), EYEGLASSES, JEWELRY, AND ANY OTHER SHARP OBJECTS.
2. SOMERSAULTS, FLIPS, DIVING, WRESTLING, AND ROUGH PLAY ARE PROHIBITED.
3. NO RIDERS UNDER THE INFLUENCE OF DRUGS OR ALCOHOL PERMITTED ON THE INFLATABLE.
4. NO FOOD, DRINKS, GUM, PETS, OR SILLY STRING ARE ALLOWED AT ANY TIME.
5. RIDERS WITH MENTAL OR PHYSICAL IMPAIRMENT SHOULD NOT BE ALLOWED TO USE THIS INFLATABLE.
6. EXIT IMMEDIATELY IF THE UNIT BEGINS TO LOSE AIR. USE EXIT DOORS AND ESCAPE HATCHES.
7. DO NOT USE AND IMMEDIATELY DEFLATE THE UNIT(S) IF WIND SPEEDS EXCEED 15 MPH AND/OR RAIN/THUNDERSTORMS ARE IN THE AREA. NEVER DEFLATE THE UNIT WHILE PEOPLE ARE ON THE INFLATABLE. TURN OFF AND UNPLUG BLOWER. WHEN WEATHER HAS CLEARED, RE-PLUG BLOWER AND TURN POWER BACK ON. WAIT FOR UNIT TO REINFLATE AND BE SURE THAT THE UNIT IS THOROUGHLY DRY BEFORE ALLOWING RIDERS ON INFLATABLE.
8. RIDERS SHOULD ALL BE OF COMPATIBLE AGE AND SIZE. CHECK SIZE/AGE CHART BELOW. NEVER EXCEED THE MAXIMUM NUMBER OF RIDERS FOR AGE GROUP. NO CHILDREN UNDER THE AGE OF 3 YRS. NO ADULTS ALLOWED ON THIS RIDE.
9. KEEP CHILDREN AWAY FROM BLOWER UNIT AT ALL TIMES.
10. BOUNCE AWAY FROM OTHERS AND SIDES OF THE UNIT.
11. DO NOT JUMP ONTO OR OFF OF THE INFLATABLE UNIT.
12. RIDERS MUST BE HELPED ONTO AND OFF OF THE INFLATABLE.
13. NO SMOKING, FIREWORKS, OR OPEN FLAME, WITHIN 50 FT. OF THE INFLATABLE.
14. DO NOT MOVE THE INFLATABLE FROM THE LOCATION IN WHICH IT WAS INSTALLED.
15. DO NOT SLIDE HEAD FIRST, CROSS ARMS AND SLIDE FEET FIRST.
16. DO NOT JUMP ON OR CLIMB UP SLIDE.

Maximum number of riders per age group. Never exceed the recommended capacities.
