

NV Moonbounce Safety Instructions

Super Splash Tropical Slide - Serial #9923

These safety rules **MUST** be followed to avoid serious injury or death.

***Supervision by a qualified attendant is required at all times.**

1. ALWAYS BE SURE THAT THE SLIDE AND POOL ARE CLEAR OF OTHERS BEFORE ALLOWING ANOTHER TO SLIDE.
2. RIDERS MUST EXIT POOL IMMEDIATELY.
3. NEVER ALLOW MULTIPLE PERSON(S) TO SLIDE AT ONCE.
4. REMOVE SHOES (AND SOCKS IF WATER IS BEING UTILIZED), EYEGLASSES, JEWELRY, AND ANY OTHER SHARP OBJECTS.
5. SOMERSAULTS, FLIPS, AND DIVING ARE PROHIBITED.
6. NO RIDERS UNDER THE INFLUENCE OF DRUGS OR ALCOHOL PERMITTED ON THE INFLATABLE.
7. NO FOOD, DRINKS, GUM, PETS, OR SILLY STRING ARE ALLOWED AT ANY TIME.
8. RIDERS WITH MENTAL OR PHYSICAL IMPAIRMENT SHOULD NOT BE ALLOWED TO USE THIS INFLATABLE.
9. EXIT IMMEDIATELY IF THE UNIT BEGINS TO LOSE AIR.
10. DO NOT USE AND IMMEDIATELY DEFLATE THE UNIT(S) IF WIND SPEEDS EXCEED 15 MPH AND/OR THUNDERSTORMS ARE IN THE AREA. NEVER DEFLATE THE UNIT WHILE PEOPLE ARE ON THE INFLATABLE. TURN OFF AND UNPLUG BLOWER. WHEN WEATHER HAS CLEARED, RE-PLUG BLOWER AND TURN POWER BACK ON. WAIT FOR UNIT TO REINFLATE BEFORE ALLOWING RIDERS ON INFLATABLE.
11. RIDERS SHOULD ALL BE OF COMPATIBLE AGE AND SIZE.
12. NEVER EXCEED THE MAXIMUM NUMBER OF RIDERS. NO CHILDREN UNDER THE AGE OF 3 YRS.
13. KEEP CHILDREN AWAY FROM BLOWER UNIT AT ALL TIMES.
14. DO NOT JUMP ONTO OR OFF OF THE INFLATABLE UNIT.
15. NO SMOKING, FIREWORKS, OR OPEN FLAME, WITHIN 50 FT. OF THE INFLATABLE.
16. DO NOT MOVE THE INFLATABLE FROM THE LOCATION IN THAT IT WAS INSTALLED.
17. DO NOT SLIDE HEAD FIRST.
18. DO NOT JUMP ON OR CLIMB UP SLIDE.
19. IF USING THE POOL, ALWAYS KEEP WATER FILLED TO THE LINE.
20. **PLEASE DO NOT DEFLATE THE SLIDE!!**

Maximum number of riders listed by age. Never exceed the recommended capacities.
